This STALLION BREEDING CONTRACT, is made and entered into by and between **IMA TALENTED GUY PARTNERS**, hereinafter designated Mare Owner, Mare Owner agrees to breed the mare

\_\_\_\_\_, Reg. No. \_\_\_\_\_, to Ima Talented Guy, for a live foal, subject to the following conditions.

1. The stallion fee includes a non-refundable booking fee of **\$400.00** payable with this contract. The remaining **\$1300.00** of the breeding fee along with any shipping fees must be paid in full **before** semen is shipped.
2. **Please return a copy of the mares' registration papers with the booking fee.**
3. Breeder requires notification from Mare Owner the day before semen is needed not no later than 9:00am central time, on the day you need the semen shipped. In the unlikely event of insufficient semen on a particular breeding day, Breeder reserves the right to determine which mares will be bred, based on reproductive status and early notification.
4. Mare shall be checked to be in healthy and sound breeding condition by a veterinarian. Any previous breeding problems shall be disclosed to Breeder. Breeder agrees to diligently try to settle mare for any reason, Mare owner will hold Breeder blameless. Mare Owner is required to have mare ultra-sounded by licensed by veterinarian 14-16 days after being bred and said results shall be sent/phoned to Breeder. Any mare not ultra-sounded 14-16 days after being bred will make the "Live Foal Guarantee" null and void.
5. This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurse without assistance. If foal is born dead, there are return privileges for the following reason only if Breeder is notified with 7 days and receives a veterinarian's statement confirming death. If mare does not check in foal or if after being pronounced "safe in foal", the mare should miscarry, abort or prove barren, Mare Owner has the privilege of a return breeding during the current breeding season or the following year. Mare Owner will be responsible for collection fee and shipping fee on all rebreeds.
6. A "Breeder Certificate" will be issued for the foal conceived by this mating when stallion fee and all other expenses have been paid in full; and, when Breeder has notified by Mare Owner that the mare has produced a live foal by this mating.
7. It is further agreed that should the stallion die, be sold by partnership, or become unfit for service prior to settling the mare; that the breeding fee not including the booking fee will be refunded to the Mare Owner. If the mare dies or becomes unfit to breed before pronounced safe in foal, the Breeder will accept another mare upon approval.
8. This Contract is nonassignable and nontransferable. This Contract is entered into in the State of Louisiana and will be interpreted and verbal or implied, is included unless specifically stated in this written Contract. When Mare Owner and Breeder sign this Contract, it will then be binding on both parties.
